1. To assure that all our vendors have a great event, only items listed on your application will be allowed to be in your display.
2. Vendors will be assigned check---in times and a staging area will be set aside to get you in and out of your spaces as quickly as possible. You will receive your time slot and space assignment (1) week prior to the event.
3. NO parking or driving on the sidewalks or brick area at any time, even loading and unloading. Parking will not be allowed on Groover Street.
4. Vendors are responsible for all setups, breakdowns and equipment necessary for their booth, including extension cords.
5. All booth sites are outdoors and canopies are recommended for inclement weather.
6. If you need to breakdown prior to 10pm, please note that on your application. Vendors are encouraged to stay through the worship service.
7. Sales and activities will be suspended during the worship service. No booth breakdown will be allowed during the worship service.
8. This is a family and faith oriented event, please do not display anything that would be inappropriate for such a venue. The committee will be forced to ask that any such items displayed be removed.
9. Appropriate dress is expected. Please do not wear tank tops, halter tops, or spaghetti strap tops. Please do not wear clothing that shows bare midriff or bare back. Please do not wear shorts that are above the thigh.
